Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44.
Authorization for admission to a home**

Specifically failed to comply with the following:

- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,**
(a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).
(b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9).
(c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).
(d) contact information for the Director. 2007, c. 8, s. 44. (9).

Findings/Faits saillants :

1. The Licensee failed to ensure, if the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; (c) an explanation of how the supporting facts justify the decision to withhold approval; and (d) contact information for the Director. 2007, c. 8, s. 44. (9).

Record review of applicant #007's referral report indicated they were referred for admission to the home in December, 2018.

Record review of the written notices from the home to the applicant and Local Health Integration Network (LHIN) dated January 2018, indicated after carefully reviewing the application and visiting the applicant the home was unable to provide appropriate accommodations, the "nursing home lacks physical facilities necessary to meet applicant's needs" and specifically the client has a history of responsive behaviours.

The written notice did not provide a detailed explanation of the appropriate accommodation and how the home lacks the physical facilities to meet the applicant's needs.

There were no supporting evidence that the legislative requirements under b, c and d were demonstrated in the written notices.

Specifically the home did not provide the applicant, the director and the appropriate placement co-ordinator:

- a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care
- an explanation of how the supporting facts justify the decision to withhold approval
- contact information for the Director [s. 44. (9)]
