s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits sayants :

1. On 18 May 2011 the inspector confirmed the following information:

An incident of verbal abuse of a resident occurred involving an employee and a resident. The verbal abuse was overheard by another employee who reported it to management. The employee had attended an in-service on respectful communication in 2009. The Abuse-Free Long Term Care Environment policy and procedure was reviewed during the annual training that the employee attended.
