The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 8, 9, 10 and 11, 2019.

The following intakes were inspected during this Critical Incident System inspection:

- Log #'s 024485-18 (CIR #2845-000022-18) and 025144-18 (CIR #2845-000023-18) related to incidents that causes an injury to a resident for which the resident was taken to hospital**
- Log # 030460-18 (CIR #2845-000027-18) related to staff to resident alleged physical abuse**
- Log # 028384-18 (CIR #2845-000025-18) related to resident to resident alleged abuse.**

During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSWs), Registered Nurses (RNs), Registered Practical Nurses (RPNs), the Director of Care (DOC), and the Executive Director (ED). The inspector also observed the provision of resident care and services, reviewed resident health care records and Licensee incident investigation notes.
