Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): February 22, 23, 24, 25, 2021.

The following intakes were inspected during this Critical Incident System (CIS) inspection:

Logs #024600-20 (CIS #2845-000016-20) and #005615-20 (CIS #2845-000003-20) - falls that caused injury which required a transfer to hospital

Log #016346-20 (CIS #2845-000011-20) - An allegation of improper treatment of a resident

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), a Registered Nurse (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), the Resident Services Coordinator, the Infection Prevention and Control Lead, a Housekeeper, and residents.

Also during the course of the inspection, the inspector completed a review of relevant documents including resident healthcare records including post-fall and skin assessments, and internal investigation interview notes. The inspector conducted observations of the entrance of the home and the screening and testing area, resident home areas and resident rooms, the provision of resident care and services, resident dining service, and housekeeping services.
