**The purpose of this inspection was to conduct a Complaint inspection.**

**During the course of the inspection, the inspector(s) spoke with Personal Support Workers, Registered Nursing Staff, a Housekeeper, a Screener, a Rapid Test Clinic staff, the Staff Scheduler, the Registered Dietitian, the Wound Care Champion, the Resident Services Coordinator, the Infection Prevention and Control Manager, the Acting Environmental Services Manager, a Geriatric Psychiatry Outreach Program Nurse, the Director of Care and the Executive Director.**

**During the course of the inspection, the inspector(s) reviewed relevant documents including residents' health care records, staff schedules and continence care product ordering and distribution forms; and observed continence care product storage areas, the provision of care and services to residents, dining service, housekeeping services, COVID-19 screening, rapid testing and other Infection Prevention and Control measures and the documentation of air temperature measurements.**
