WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants:

- 1. The licensee failed to protect residents from abuse by anyone.
- a) In 2012, a specified resident was treated roughly by a staff member causing pain in the leg and leaving the resident feeling threatened.
- i) The resident's leg was grabbed by the staff member and the resident felt as if they were being thrown over to the side of the bed, causing pain.
- ii) The resident indicated during interview that they felt threatened by the identified staff member and that the staff member made them feel as if they were "in the way" and fearful to ring the call bell. The resident described the staff member as being "annoyed" and "worked up".

The specified resident was not protected from verbal and physical abuse by a staff member.

- b) In 2011, a specified resident was grabbed by a co-resident causing a scratch to the neck and choking pressure from the clothing as it was pulled by the co-resident.
- i) The co-resident had been exhibiting an exacerbation in responsive behaviours, with four previous documented incidents of verbal and physical aggression directed at staff and residents over a three month period in 2011.

In 2011, the specified resident was not protected from abuse by anyone.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that residents are protected from abuse by anyone, to be implemented voluntarily.
