The purpose of this inspection was to conduct a Critical Incident System inspection.

A concurrent Complaint Inspection #2018_776613_0003 was also conducted during this inspection, and three on-site inquiries.

During the course of the inspection, the inspector(s) spoke with the Administrator, Executive Director of Care (EDOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), and residents.

The Inspector also conducted daily tours of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, reviewed health care records, internal investigations, and policies, procedures and programs.
