WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 230. Emergency plans

Specifically failed to comply with the following:

s. 230. (8) The licensee shall keep current all arrangements with community agencies, partner facilities and resources that will be involved in responding to emergencies. O. Reg. 79/10, s. 230 (8).

Findings/Faits saillants :

1. With the installation of a 400 amp generator transfer switch, it was noted that the homes' contingency plan for loss of power has not been updated to address the transfer switch, person responsible for activating the switch and/or actions required by home staff. [s. 230. (8)]
