During this critical incident inspection, two critical incidents Log # 035047-16 and Log # 035366-16, related to alleged resident to resident abuse, were inspected.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, Registered Nurses, Registered Practical Nurses, Personal Support Workers, Personal Support Workers from the Mobile Response Team, and Residents. As well, the inspector observed resident care, reviewed resident health care records and the home's Responsive Behaviours Policy.
