Specifically failed to comply with the following subsections:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. A resident received an injury from a co-resident.

The agitated resident was not provided with increased monitoring or distractions to reduce the agitation as directed in the plan of care.

Staff failed to follow the plan of care for the resident with responsive behaviors.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure all staff are providing care to residents with responsive behaviors in accordance with the plan of care, to be implemented voluntarily.
