WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 46. Every licensee of a long-term care home shall ensure that every member of the staff who performs duties in the capacity of registered nurse, registered practical nurse or registered nurse in the extended class has the appropriate current certificate of registration with the College of Nurses of Ontario. O. Reg. 79/10, s. 46.

Findings/Faits saillants :

1. The licensee has failed to ensure that every registered nursing staff member has the appropriate current certificate of registration with the College of Nurses of Ontario.

A new employee was hired as a Registered Staff Member and worked an identified number of scheduled shifts before it was known that the staff member was suspended by the College of Nurses of Ontario.

In an interview, the Staff Educator and Director of Care confirmed there was no documented evidence that the home verified the staff member had the appropriate current certificate of registration with the College of Nurses.

The Administrator confirmed there is a process in place to ensure that registered staff has the appropriate current certificate of registration, the process was not followed and the expectation is that every registered nursing staff have the appropriate current certificate of registration with the College of Nurses of Ontario.
