WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

- s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,
- (a) a goal in the plan is met;
 - (b) the resident's care needs change or care set out in the plan is no longer necessary; or
 - (c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. The licensee did not ensure the plan of care was revised when the resident's care needs changed. Resident #1 demonstrated inappropriate responsive behaviour toward another resident in 2012. The documents that are used to communicate care needs of the resident, specifically the long and short version of the care plan and kardex, which were reviewed by the Compliance Inspector, did not include this new behaviour or intervention to manage it despite the fact staff and documentation in the progress notes confirmed the resident was on increased monitoring. s.6(10)(b)

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the resident's plan of care is reviewed and revised when the resident's care needs change, to be implemented voluntarily.
