- One intake, regarding CO #001, related to s.101(3) of the Ontario Long-Term Care Homes Act (LTCHA), 2007.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Nurse Manager (NM), the Long-Term Care (LTC) Lead, the Nurse Educator (NE), the Administrative Assistant (AA), the Registered Dietitian (RD), the Activity Coordinator (AC), a Housekeeping Aide (HA), Registered Practical Nurses (RPNs), a Personal Support Worker (PSW), and residents.

The Inspector also conducted a tour of the resident care areas, observed staff-to-resident interactions, and reviewed the home's supporting documentation, including staff training and auditing records, as well as specific licensee policies, procedures and programs.

During the course of this inspection, Non-Compliances were not issued.
