WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 48. Required programs

# Specifically failed to comply with the following:

- s. 48. (1) Every licensee of a long-term care home shall ensure that the following interdisciplinary programs are developed and implemented in the home:
- 1. A falls prevention and management program to reduce the incidence of falls and the risk of injury. O. Reg. 79/10, s. 48 (1).
- 2. A skin and wound care program to promote skin integrity, prevent the development of wounds and pressure ulcers, and provide effective skin and wound care interventions. O. Reg. 79/10, s. 48 (1).
- 3. A continence care and bowel management program to promote continence and to ensure that residents are clean, dry and comfortable. O. Reg. 79/10, s. 48 (1).
- 4. A pain management program to identify pain in residents and manage pain. O. Reg. 79/10, s. 48 (1).

## Findings/Faits saillants:

1. The licensee has failed to ensure that there is an interdisciplinary falls prevention and management program developed and implemented in the home, with the aim to reduce the incidence of falls and the risk of injury as evidenced by:

There is no documented evidence that there is an interdisciplinary falls prevention and management program developed and implemented in the home, with the aim to reduce the incidence of falls and the risk of injury.

There is no evidence of a written description of the program that includes its goals and objectives and relevant policies and procedures and protocols and provides for methods to reduce risk and monitor outcomes.

The Director of Care confirmed there is no an interdisciplinary falls prevention and management program developed and implemented in the home, with the aim to reduce the incidence of falls and the risk of injury, as well as the expectation is the program be developed and implemented in the home. #### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that there is an interdisciplinary falls prevention and management program developed and implemented in the home, with the aim to reduce the incidence of falls and the risk of injury, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 221. Additional training — direct care staff

Specifically failed to comply with the following:

- s. 221. (1) For the purposes of paragraph 6 of subsection 76 (7) of the Act, the following are other areas in which training shall be provided to all staff who provide direct care to residents:
- 1. Falls prevention and management. O. Reg. 79/10, s. 221 (1).

# Findings/Faits saillants:

1. The licensee failed to ensure all direct care staff are provided training in falls prevention and management as evidenced by:

A review of the home's mandatory training records, including falls prevention, revealed 46 (55.42%) of the 83 nursing staff members were not provided training in falls prevention and management.

The Director of Care and Assistant Director of Care confirmed not all direct care staff were provided training in falls prevention and management, no training in falls prevention and management was provided in 2013 and the expectation is all direct care staff are provided training in falls prevention and management.
