1. The Licensee has failed to ensure the infection prevention and control program has been implemented.

Observations made revealed plastic wash basins were sitting on the washroom floor in six (6) resident rooms.

A Staff interview with a Registered Practical Nurse and the Executive Director confirmed the home's expectation is that the basins will be stored in the cupboards in the Bathroom or on the shelf/top of cabinets but not on the floor. [s. 229. (4)]

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure all staff participate in the implementation of the Infection Prevention and Control Program, to be implemented voluntarily.***
