The purpose of this inspection was to conduct a Resident Quality Inspection.

This inspection was conducted on the following date(s): November 6-10, 2017.

The following additional intakes were submitted to the Director and were inspected during this Resident Quality Inspection (RQI).

One Critical incident (CI), was related to alleged abuse between a staff member and a resident and the second CI, was related to an unexpected death.

An additional intake that was inspected during the RQI, was related to the deferred 2016 Resident Focus-RQI Quality of Care and Quality of Life indicators.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Resident Care (DOC), Dietary/Environmental Supervisor, Registered Dietitian (RD), Registered Nurses (RN's), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), residents, and family members.

During the course of the inspection, the Inspector(s) directly observed the delivery of resident care, staff to resident and, resident to resident interactions, conducted a daily tour of resident home areas, reviewed resident health care records, various home policies, procedures and programs and reviewed staff education records.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 74. Registered dietitian

Specifically failed to comply with the following:

s. 74. (2) The licensee shall ensure that a registered dietitian who is a member of the staff of the home is on site at the home for a minimum of 30 minutes per resident per month to carry out clinical and nutrition care duties. O. Reg. 79/10, s. 74 (2).

Findings/Faits saillants:

1. The licensee has failed to ensure that a Registered Dietitian (RD) who was a member of the staff of the home was on site at the home for a minimum of 30 minutes per resident per month to carry out clinical and nutrition care duties.

Resident #003 was identified as having experienced an eating decline through a Minimum Data Set (MDS) assessment from the Admission to 90-day MDS assessment.

Inspector #681 reviewed resident #003's electronic medical record, which indicated that a nutrition assessment had not been completed by a RD since resident #003's admission assessment, which was completed on a specific date.

During an interview with Inspector #681, the Registered Dietitian #104 stated that they had a contract with the home for 39 hours per month; however, only 22 of these hours were completed on site and the remainder of the hours were worked from a remote location.

During an interview with Inspector #681 on November 9, 2017, the Administrator of the home stated that, based on the occupancy of the home, the required number of dietitian hours were 39 hours per month. However, the contract between the licensee and RD #104 did not stipulate the number of hours that had to be completed as site hours compared to the number of hours that could be worked remotely. The Administrator stated that RD #104's usual schedule was to work in the home for 22 hours per month and that the remaining 17 hours per month were worked from a remote location. The Administrator acknowledged that RD #104 was not in the home for the required 39 hours per month. [s. 74. (2)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the Registered Dietitian provides on site at the home, a minimum of 30 minutes per resident per month, to carry out clinical and nutrition care duties, to be implemented voluntarily.
