The purpose of this inspection was to conduct a Critical Incident System inspection.

- One log which was related to an incident in which the resident was taken to hospital and resulted in a change to their health condition; and**
- One log which was related to a missing controlled substance.**

During the course of the inspection, the inspector(s) spoke with the Administrator, acting Director of Care, Registered Practical Nurses (RPN), Personal Support Workers (PSW) and resident.

The Inspector also conducted a daily tour of resident care areas, reviewed relevant resident health care records, staff to resident interactions and observed the provision of care and services to the residents.
