The purpose of this inspection was to conduct a Critical Incident System inspection.

This Critical Incident Inspection was in regards to an allegation of resident to resident abuse.

During the course of the inspection, the inspector(s) spoke with a resident, Personal Support Workers (PSWs), Housekeeper, Registered Practical Nurse (RPN), Registered Nurse (RN), Psychogeriatric Nurse, Manager of Resident Care, PSW Supervisor, Director of Care, Acting Director of Care, Director of Community Outreach and Programming, Ottawa Police Department Constable, Ottawa Police Department Sargent.

During the course of the inspection the inspector also reviewed resident records, including progress notes, assessments, plans of care, Medication Administration Records, Physician Orders, consultation notes, and observed residents and resident care.
