The purpose of this inspection was to conduct a Follow up inspection.

This inspection is a follow-up to the compliance order originally issued in November 2013.

During the course of the inspection, the inspector(s) spoke with the Chief Executive Officer, the Chief of Resident Care (LTC), the Director of Nursing Practice, several Registered Nurses, several Registered Practical Nurses, a Director of Resident Care and a Manager of Resident Care.

During the course of the inspection, the inspector(s) reviewed the following:
