Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 27, 28, February 3, 4, 5, 6, and 7, 2020.

The following intakes were inspected as part of this Critical Incident System inspection:

log #001040-20 related to an incident that causes an injury to a resident for which the resident is taken to hospital and which results in a significant change in the resident's health status,

log #001565-20 related to abuse of a resident that resulted in harm to the resident.

During the course of the inspection, the inspector(s) spoke with the Administrative Assistant, the Administrator, the Manager, Personal Care, the Manager, Resident Care, a personal support worker, registered practical nurses, a registered nurse, and the Staffing Coordinator.

The inspector also reviewed health care records, observed resident to resident interactions, and observed a resident home area including specific resident rooms.
