Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 18, 21-23, 2022.

The following intakes were completed during this Critical Incident System Inspection:

Log #000472-22, Log #000152-22, and Log #021016-21 related to falls prevention.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Resident Assessment Instrument (RAI) / Continuous Quality Improvement (CQI) Coordinator, IPAC Registered Nurse (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), Housekeeping staff, Recreation Aides, and residents.

During the course of the inspection, the inspector reviewed clinical health records, relevant policies and procedures, and other documents, observed the provision of resident care, and resident and staff interactions.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the fall prevention and management care plan was implemented for a resident as specified in the plan.

The resident was at risk for falls and had cognitive and physical impairments. Their falls prevention and management plan of care included three specified interventions implemented for the resident. During an observation, these three specified interventions were not provided to the resident as specified in the plan of care.

By not providing the falls prevention and management interventions as per the plan of care, this placed the resident at risk for falls and injury.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that fall prevention and management is implemented for residents as specified in the plan, to be implemented voluntarily.
