This Follow-Up Inspection is related to Compliance Order #001, originating from Resident Quality Inspection (RQI) Log #029789-16 to inspect the home's West Front Door (main exit door) which was missing a manual reset switch.

During the course of the inspection, the inspector(s) spoke with the Administrator/Director of Care (DOC), Environmental Services Supervisor, registered staff, personal care workers, and family members & residents.

The Inspector observed the functioning of the west front door, observed residents, staff and visitors entering/exiting the home, and reviewed related documentation.
