The purpose of this inspection was related to a critical incident the home submitted regarding an unexpected death of a resident.

During the course of the inspection, the inspector(s) spoke with residents, personal support workers, food services attendants, registered nurses, the home's dietician and the Director of Care/Administrator.

At the time of the inspection the inspector reviewed; resident health care files, including written plans of care and assessments, three week menus at a glance for menu items on the day of the incident and the home's investigation documentation related to this critical incident. The inspector observed staff to resident and resident to resident interactions in the home's main dining room.
