The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 22-March 3, 2021.

The following intake was completed in this follow up Inspection;

-One log related to compliance order (CO) #001 that was issued during Inspection #2020_853692_0007 ensuring that the home was compliant with s. 19. (1) of the Long-Term Care Homes Act, specifically related to the protecting all residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff.

A Critical Incident Inspection (2021_772691_0006) and Complaint Inspection (2021_772691_0007) were conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Associate Director of Care (ADOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Worker (PSWs), Resident Care Aides (RCAs), and residents.

The Inspector (s) also conducted a daily tour of resident care areas, observed the provision of care to residents, observed staff to resident interaction, reviewed relevant health care records, internal investigation notes, staff education records, as well as relevant policies and procedures.
