The purpose of this inspection was to conduct a follow-up inspection to a Compliance Order #001 served on October 22, 2010. (Log # O-000920, Inspection # 2010-188-9567-29Sept103811)

During the course of the inspection, the inspector spoke with the home's Director of Care, the home's nurse clinician consultant, two Registered Practical Nurses, to a Personal Support Worker and a resident.

During the course of the inspection, the inspector reviewed a resident's health care record, reviewed the home's 24-hour shift report for Feb 22 and 23 2011, reviewed the home's policy on 24-hour Report #PRO-854, revised 11/2010, reviewed the home's mandatory education in-service listings given on Documentation October 13 and November 2 as well as in-services held on December 8 2010 regarding – 24-hour reports, critical incidents, abuse, responsive behaviours and complaints.
