The purpose of this inspection was to conduct a Resident Quality Inspection.

This inspection was conducted on the following date(s): October 3, 4, 5, 6, 10, 11,12, 13, 2017

During the course of the inspection, the inspector(s) spoke with Administrator, the Director of Care (DOC), the Food Service Supervisor/Recreation and Programs Manager, one Physiotherapist Assistant, , the Clinical Care Coordinator, several Registered Nurses (RN), several Registered Practical Nurses (RPN), several Personal Support Workers (PSW), one Activity staff, one Food Service Worker, Housekeeping Aides, the Receptionist, the Administrator's Assistant, the President of the Resident Council, the President of the Family Council, several families and several residents.

In addition, the inspectors reviewed resident health care records, policies related to infection control, restraints, reviewed staffing schedules. Inspectors observed resident care and services, staff and resident interactions.

1. The licensee has failed to ensure that there was at least one registered nurse (RN), who is an employee of the licensee and a member of the regular nursing staff on duty and present at all times, except as provided for in the regulations.

Residence Prescott and Russell is a 146 bed Long-Term Care home.

Review of the Residence Prescott and Russell's RN staffing schedule for the period from September 24, 2017 to October 7, 2017. It was noted that on the following shift, was identified as not having an RN present in the home for the whole shift:

September 9, 2017 on the night shift, there was no Registered Nurse on site for a period of 3.5 hours, between 0130 and 0500 hours.

Ontario Regulation 79/10 section 45 (2) indicates that "emergency" means an unforeseen situation of a serious nature that prevents a Registered Nurse from getting to the Long-Term care home.

On October 13, 2017, Unit clerk #108 indicated to Inspector #126 that the absence was not related to an emergency situation.

On October 13, 2017, the Nursing Care Supervisor indicated to Inspector # 126 that the absence was not related to an emergency situation.

They both indicated that on the Night Shift of September 9, 2017, there was no RN on site for 3.5 hours period and that period was covered by an RN on call. [s. 8. (3)]
