1. The licensee has failed to ensure that when applications for admission in the home were withheld, the licensee shall give to the applicants a written notice setting out: (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care, and (c) an explanation of how the supporting facts justify the decision to withhold approval.

The licensee withheld application of approval for admission to the home due to the applicants' assessed behaviours, and sent each of them a written notice.

The written notice for the first applicant stated that the staff of the home lack the nursing expertise necessary to meet the applicant care requirements related to behavioural assessment information of potential identified risk contained in the application.

The written notice for the second applicant stated that the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements related to identified responsive behaviours.

The written notice for the third applicant stated that the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements, related to potential identified behaviour.

All three written notices did not provide a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care, and an explanation of how the supporting facts justify the decision to withhold approval.

Therefore, all written notices sent to the applicants by the home did not set out the required details contained in s. 44. (9)(b)(c) of the Act .

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance when the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; and (c) an explanation of how the supporting facts justify the decision to withhold approval, to be implemented voluntarily.
