The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 21- 24, 2016

The critical incident(s) concerned two injuries suffered by the same resident both of which which required transfer/admission to hospital.

During the course of the inspection, the inspector(s) spoke with personal support workers, registered staff, the Director of Care, the Administrator and residents. The inspector reviewed resident health records, interviewed staff, reviewed the Home's investigation documentation and relevant fall prevention related policies, procedures and education material. Multiple observations of care and service delivery throughout the home were also completed as part of the inspection.
