The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): June 6 - 9, 2016.

This Complaint Inspection is related to a complaint regarding the home's elevators.

During the course of the inspection, the inspector(s) spoke with the Director of Care and the Facilities Manager.

The Inspector reviewed the operating licence in place for each of home's four elevators, as issued by the Director of the Technical Standards and Safety Authority (TSSA). The Inspector reviewed the elevator maintenance contract in place with ThyssenKrupp, which covers the home's four elevators. The Inspector reviewed the maintenance log book, maintained by Thyssen Krupp elevator technicians, for the elevator that serves the main lobby and the Sydenham unit, elevator #4. The Inspector reviewed the licensee's written elevator contingency plan, in place to manage elevator malfunctions and elevator entrapments. The Inspector reviewed the entrapment reports (a.k.a "occupied" report) for each of the four elevators, as was provided to the Facilities Manager by ThyssenKrupp.
