The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted in reference to intake logs #002771-21 - CIS #3005-000009-21; #002484-21 - CIS #3005-000008-21; #004533-21 - CIS #3005-000018-21; #024988-20 - CIS #3005-000053-20; and #004113-21 – CIS #3005-000017-21 related to residents having fallen resulting in an injury, and intake logs #003460-21 – CIS #3005-000015-21; #025502-20 – CIS #3005-000054-20; and #000606-21 – CIS #3005-000004-21 related to responsive behaviours of residents resulting in an injury to another resident.

During the course of the inspection, the inspector(s) spoke with the administrator, the Director of Care, the Assistant Director of Care, the Infection Prevention and Control Lead, the Regional Director of Infection Prevention and Control for the Licensee, the RAI Coordinator, the Assistant RAI coordinator, Registered Nurses, Registered Practical Nurses, Personal Support Workers, Physiotherapy Assistant, and residents.

During the course of the inspection, the inspectors conducted a tour of the home, made dining room and resident care observations, reviewed resident health care records, observed and reviewed infection control practices, and policies and procedures related to Infection Prevention and Control, Falls Prevention and Responsive Behaviours.
