Specifically failed to comply with the following:

s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,

(a) a goal in the plan is met; 2007, c. 8, s. 6 (10).

(b) the resident's care needs change or care set out in the plan is no longer necessary; or 2007, c. 8, s. 6 (10).

(c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. The licensee failed to ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when, (b) the resident's care needs change or care set out in the plan is no longer necessary. 2007, c. 8, s. 6 (10).

Interview with the General Manager revealed that an identified resident had a particular medical condition.

Record review of the Clinical record in Point Click Care revealed that the identified resident received care from a staff member, as documented in the Progress Notes.

Record review of the Plan of Care revealed that this particular care was to be completed by specifically identified staff.

Interview with the Director of Care confirmed that the Plan of Care was not updated with the change in Care provider and that it is the expectation that the Plan of Care should be current. [s. 6. (10) (b)]
