The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): April 5, 6 and 7, 2017.

Critical incident Report log #027635-16 related to allegations of resident to resident sexual abuse.

During the course of the inspection, the inspector(s) spoke with the General Manager (GM), Director of Care (DOC), Registered Practical Nurse (RPN) and Personal Support Workers (PSW).

Also during the course of the inspection, the inspector toured the home, observed staff to resident interactions, and resident to resident interactions, reviewed resident clinical health records and the licensee's investigation documentation.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

Findings/Faits saillants :

1. The licensee has failed to ensure that a person who had reasonable grounds to suspect that abuse of a resident by anyone that resulted in harm or risk of harm to a resident did not immediately report the suspicion and the information upon which it was based to the Director.

Related to log #027635-16:

Inspector #601 reviewed a Critical Incident Report (CIR) that was reported to the Ministry of Health and Long-Term Care (MOHLTC) after hours action line on an identified date and time.

The CIR indicated that PSW #101 witnessed resident #002 demonstrating sexually inappropriate behaviours towards resident #001.

During an interview, the General Manager (GM) indicated to Inspector #601, that RN #100 made her aware of the incident involving resident #001 and #002 at the time the incident occurred. During the same interview, the GM indicated that upon becoming aware of the incident the MOHLTC after hours action line should have been immediately notified.

The Director was notified the day after the incident. [s. 24. (1)]
