A Complaint Inspection log #035127-15/IL-41092-15 regarding staffing was completed during this Resident Quality Inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, five Registered Nurses, four Registered Practical Nurses, seven Personal Support Workers, thirty residents, three resident's family members, the Resident's Council President and the Family Council President.
