The purpose of this inspection was to conduct a Resident Quality Inspection inspection.

This inspection was conducted on the following date(s): August 8 - 12, 2016.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Nursing, the Maintenance Supervisor, the Activities Director, the Nutrition Manager, the President of the Family Council, a member of the Resident's Council, two Registered Nurses, three Registered Practical Nurses, four Personal Support Workers, one Nurses Aide, one Personal Support Worker summer student, one Rehab Therapist, two Family Members and 20+ Residents.

During the course of the inspection, the inspector(s) observed all resident home areas, recreational activities, medication rooms and administration, the provision of resident care, staff/resident interactions, resident/resident interactions and infection prevention and control practises.
