During the course of the inspection, the inspector reviewed the applicant's health information and assessments provided to the home by the Local Health Integration Network (LHIN) and the additional information requested by the home from the LHIN including a letter from the applicant's physician.

#### Specifically failed to comply with the following:

- s. 44. (7) The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,
- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).
- (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).
- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,
- (a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).
- (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9).
- (c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).
- (d) contact information for the Director. 2007, c. 8, s. 44. (9).

### Findings/Faits saillants:

- 1. The licensee has failed to approve applicant #001's admission to the home in accordance with the allowable reasons outlined in s. 44 (7) of the LTCHA to withhold approval.
- LTCHA, 2007, s. 44(7) states, the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,
- (a) The home lacks the physical facilities necessary to meet the applicant's care requirements;
- (b) The staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or
- (c) Circumstances exist which are provided for in the regulations as being a ground for

withholding approval.

On an identified date, this inspector interviewed DOC #100 in regards to the home's reason for withholding applicant #001's admission to the home. DOC #100 provided this inspector with reasons that were not allowable under the legislation. DOC #100 stated they also had concerns related to applicant #001's responsive behaviours that were documented from an identified assessment completed eight months earlier. DOC #100 stated they were unsure if the applicant had any current responsive behaviours.

This inspector reviewed the most updated information provided by the Local Health Integration Network (LHIN) with DOC #100. This assessment stated applicant #001 was no longer experiencing the behaviours outlined in the previous assessment and identified the medication that was being used to address the behaviours.

DOC #100 was agreeable to reconsidering the applicant's admission and indicated they would contact the LHIN for any additional, updated information.

On two identified dates, the home was provided with additional information from the applicant's physician and the LHIN indicating the previous responsive behaviours outlined in the initial assessment were no longer present. The physician indicated in a letter that they had known the applicant for a period of three years and indicated there were no safety risks associated with this applicant's admission into a long-term care home.

On an identified date, this inspector spoke with DOC #100 and the Administrator in regards to the home's decision for this applicant now that updated, additional information had been provided to the home. The home declined the applicant and indicated the home lacked the nursing expertise to manage the multiple behaviours documented in the past twelve months.

The licensee failed to approve the applicant's admission to the home in accordance with the allowable reasons outlined in s. 44 (7) of the LTCHA to withhold approval. [s. 44. (7)]

2. The licensee has failed to ensure that when withholding approval for admission, the licensee provided a detailed explanation of the supporting facts as they relate both to the home and the applicant's condition and requirements for care, and an explanation of how the supporting facts justify the decision to withhold approval.

On an identified date, DOC #100 provided this inspector with a letter that indicated the application was being withheld due to the documented multiple behaviours within the past twelve months and that the home was unable to accept the application due to the lack of nursing expertise.

The letter failed to provide a detailed explanation of the supporting facts as they relate to the applicant's condition and requirements for care and an explanation of how the supporting facts justify the decision to withhold approval. [s. 44. (9)]

#### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure the licensee approves the applicant's admission to the home unless the application is being withheld based on the legislated reasons for withholding approval as outlined in LTCHA, 2007, s. 44 (7) and to ensure when withholding approval for admission, the licensee provides a detailed explanation of the supporting facts as they relate both to the home and the applicant's condition and requirements for care including an explanantion of how the supporting facts justify the decision to withhold approval, to be implemented voluntarily.
