Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits sayants:

1. Review of the home's file indicates that a staff member reported an incident that occurred in the home involving a specified resident and a registered staff member.

The specified resident was spoken to inappropriately, and undesirable actions were carried out by staff, causing discomfort for the resident.

The specified resident was not protected from abuse.

2. Review of the home's file indicates that staff working the night shift spoke inappropriately to a specified resident on one or more occasions.

The resident was able to confirm a specific threat from staff. A staff member of the home indicated that a care giver had discussed the threat to the specified resident. The specified resident indicated that as a result of treatment received they cry a lot and are afraid.

The specified resident was not protected from abuse.
