The purpose of this inspection was to conduct a Follow up inspection.

The following intake was inspected during this inspection:

One Follow up related to compliance order #001 under s. 229 (4) of the Ontario Regulation 79/10, issued during inspection #2020_805638_0016 related to ensuring that the staff participated in the implementation of the Infection Prevention and Control (IPAC) program.

A concurrent Complaint Inspection #2021_669642_0009; a Critical Incident Inspection #2021_669642_0010; and a Director Order Follow-Up Inspection #2021_669642_0007 were conducted during this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), the Co-Director of Care/Infection Prevention Program Lead, Registered Dietitian (RD), Housekeeping staff, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and residents.

The Inspector(s) also conducted daily tours of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, reviewed health care records, staff training records, audits and reviewed the licensee's compliance action plan and Infection Prevention and Control program.
