Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 7-11 and February 14-18, 2022.

The following three intakes were inspected upon during this Follow Up (FU) inspection:

-One intake (Compliance Order (CO) #001) issued during inspection #2021_864627_0024, under s.19. (1) of the Long-Term Care Homes Act, 2007 S.O. 2007, c.8, whereby residents were to be protected from neglect by the licensee or staff;

-One intake (CO #002) issued during inspection #2021_864627_0024, under s. 107. (3) of Ontario Regulation (O. Reg) 79/10, whereby the Director was to be informed no later than one business day after the occurrence of the incident that caused an injury/significant change to a resident's health condition for which the resident was taken to a hospital; and

-One intake (CO #001) issued during inspection #2021_901759_0014, under s. 8. (1) of O. Reg 79/10, whereby the home's required Falls policy was to be complied with.

A Critical Incident System inspection #2022_899609_0004 and a Complaint inspection #2022_899609_0003 were conducted currently with this inspection.

During the course of the inspection, the inspector(s) spoke with residents and their families, the Administrator, Regional Manager, Administrative Assistant, Scheduler, Director of Care (DOC), Co-Directors of Care (Co-DOCs), Nurse Practitioner (NP), Infection Prevention Program (IPAC) Lead, Housekeeping staff, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), and Screeners.

The Inspector(s) also conducted daily tours of resident care areas, observed the provision of care to residents, observed staff and resident interactions, reviewed relevant health care records, audits, compliance action plans, internal investigation notes as well as the home's relevant policies, procedures and programs.
