**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8.  
Nursing and personal support services**

**Specifically failed to comply with the following:**

**s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).**

**Findings/Faits saillants :**

1. A Critical Incident System report was submitted to the Director in January 2014. The report identified that for a part of a day shift, the home did not have a RN on duty and present due to the scheduled RN being ill and a replacement RN was not available. During the inspection, an interview was conducted with management staff member #100 and it was reported that on the particular day in January 2014, they had worked as the RN from 0700hrs to 0900hrs, left the home for a three hour period and then worked as the RN from 1200hrs to 1400hrs until the evening shift RN came on duty.

On a day in January 2014, for an approximate time period of three hours, the home did not have a registered nurse on duty and present.

The licensee failed to ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. [s. 8. (3)]
