The purpose of this inspection was to conduct an Other inspection.

This inspection was conducted on the following date(s): June 20 - 22, 2018.

This inspection was conducted to follow up on compliance order (CO) #001, issued during inspection #2017_633577_0015, related to plan of care. Specifically:

The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. LTCHA, 2007, c. 8, s. 6 (7).

The licensee shall ensure:

- 1) That all residents requiring oral nutrition supplements are provided the supplement that is ordered and that there is a documented record of the resident receiving the supplement.**
- 2) That staff are aware of their responsibilities in administering oral nutrition supplements, whether it is part of the Medication Pass, during meals or as part of the between meal nourishment.**
- 3) That all staff are kept aware of all residents care needs to ensure that the care is provided as per the care plan, ensuring quality of care and quality of life.**

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), and Registered Practical Nurses (RPNs).

The Inspector observed the provision of care and services to several residents, and reviewed employee education sessions and associated training records.
