1. The licensee failed to ensure that when they withheld approval for admission, the licensee did not give to persons described in subsection (10) a written notice setting out, (a) the ground or grounds on which the licensee is withholding approval; (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; (c) an explanation of how the supporting facts justify the decision to withhold approval; and (d) contact information for the Director.

The Ministry of Health and Long Term Care, Centralized Intake Assessment and Triage Team (CIATT), received a letter on an identified date, from the Admission Coordinator, related to applicant #001.

The letter identified that after a review of the documentation received from the Local Health Integration Network (LHIN), the home was unable to approve applicant #001s admission.

In an interview with the ADRC it was confirmed that the written notice to withhold approval did not include a detailed explanation of the supporting facts, as they related to both the home, and to applicant #001. The written notice also did not include an explanation of how the supporting facts justified the withholding of the approval or the contact information for the Director. [s. 44. (9)]

2. The licensee failed to ensure that written notice for withholding approval for admission was provided to the applicant.

The Ministry of Health and Long Term Care, Centralized Intake Assessment and Triage Team (CIATT), received a letter on an identified date, from the Admission Coordinator, related to applicant #001.

The letter identified that after a review of the documentation received from the LHIN, the home was unable to approve applicant #001s admission. A copy of this letter was not provided to the applicant.

In an interview with the ADRC, it was confirmed that the written notice to withhold approval was not provided to the applicant. [s. 44. (10) 1.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that when they withhold approval for admission, the licensee gives, to persons described in subsection (10) a written notice setting out, (a) the ground or grounds on which the licensee is withholding approval; (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; (c) an explanation of how the supporting facts justify the decision to withhold approval; and (d) contact information for the Director, and that the letter is provided to the applicant, to be implemented voluntarily.
