The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 18 to 22, 2019.

The following intakes were inspected upon during this Follow up Inspection:

- One intake for compliance order #002 from inspection #2019_790730_0019, regarding r. 135.(3) of the Long Term Care Home's Act, related to a quarterly review of all medication incidents and adverse drug reactions; and
- One intake for compliance order #003 from inspection #2019_790730_0019, regarding r. 136. (2) of the Long Term Care Home's Act, related to the home's drug destruction and disposal policy: Log #015182-19.

A Complaint Inspection #2019_794749_0026 and a Critical Incident Inspection #2019_794749_0027 were conducted concurrently with this Inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Manager of Quality and Compliance, Registered Nurses (RNs), and Registered Practical Nurses (RPNs).

Inspector(s) also conducted daily tours of the resident care areas, observed the provision of care towards residents, reviewed relevant licensee policies, procedures, programs, internal investigation documents and resident health care records.
