**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care**

**Specifically failed to comply with the following subsections:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits saillants :**

1. These findings are in relation to CIS Inspection log # 0-001508-11.

The plan of care for toileting a resident indicated that two staff are to assist with toileting related to inconsistent weight bearing. The resident was left unattended by a Personal Support worker and sustained a fall. Xrays indicated the resident had sustained a fracture.

The Director of Nursing reported to the inspector that Personal Support Workers (PSW's) are instructed not to leave residents unattended while toileting if the residents are at risk for falls.
