WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee failed to ensure that the care set out in the plan of care related to a care item was provided as per the plan of care.

Resident #001's plan of care indicated that the Resident was to get care by female staff only. A review of resident progress notes indicated that the resident received a care by a male staff member, one one occasion. The Resident indicated that they did not feel comfortable receiving showers from a male staff member. PSW #109 indicated that they were not aware of the requirement in the plan of care. As a result, the resident choices were not followed during this instance, and put the resident's dignity at risk.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.
