**The purpose of this inspection was to conduct a Complaint inspection.**

**This inspection was conducted on the following date(s): April 4,5,8 - 2013**

**During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Infection Control Nurse/RAI coordinator, the Maintenance manager, the Department Assistant and Occupational Health and Safety Representative, Registered and non registered nursing staff, residents and a resident's family member.**

**During the course of the inspection, the inspector(s) reviewed components of two resident's health care record, went into 3 rooms closed at the time of the inspection due to odour in order to verify if the odour persisted and to observed remediation work that had been completed and remediation work that was underway, viewed detailed pictures related to this remediation work and of areas of structural concern around bedroom windows, reviewed documentation related to the progression of the odour issues and remediation work February through April 2013, reviewed air sample results from the company Pinchin Environmental taken in February 2013, reviewed a draft April 2013 Pinchin Environmental assessment report of the cause of the odours and possible long term solutions.**

**There are no findings of Non-Compliance as a result of this inspection.**
