The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 2, and 3, 2021.

The following intake was inspected during this inspection: Log #000886-21, related to alleged abuse.

During the course of the inspection, the inspector(s) spoke with The Administrator, Director of Care (DOC), Resident Care Program Supervisor, Behavioural Support Ontario (BSO) lead, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), and residents.

The inspector also toured the home, observed the provision of care and services, reviewed relevant documents, including but not limited to clinical records, policies and procedures, and internal investigation notes.

The following Inspection Protocols were used during this inspection: Infection Prevention and Control Prevention of Abuse, Neglect and Retaliation

The licensee has failed to ensure that a person who was aware of an allegation of abuse of a resident, failed to take the necessary actions as outlined in the home's policy.

A staff member reported to the Action Line, that a resident alleged that a staff member abused them. The home was not made aware of this allegation until two weeks later, after they were notified by the Ministry of Long-Term Care (MLTC) Homes Inspector.

The home's policy titled "Resident Safety and Abuse", stated that any employee, who was aware of, or suspected resident abuse must ensure the resident was assessed and was safe, document the details as soon as possible, provide the details to the home's administrative staff and participate and cooperate in the investigation.

By the staff person not reporting the alleged abuse to the home's administrative staff, the investigation was not initiated immediately, which put residents at potential risk of harm.

### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that a person who is aware of an allegation of abuse of a resident, takes the necessary actions as outlined in the home's policy,, to be implemented voluntarily.
