The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): September 15, 20, 21, 22, 23, 2021.

The following intakes were included in this inspection:

Log #009625-21 related to prevention of abuse, hospitalization and change in condition and pain management and Log #014069-21 related to pain management.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RN/RPN), Personal Support Workers (PSW), former staff member, and a Substitute Decision Maker.

Observations were completed of resident home areas, Infection Prevention and Control (IPAC) procedures, staff to resident interactions and general care and cleanliness of the home.

The following records were reviewed including but not limited to: resident progress notes, care plans, electronic medication administration records (eMAR), electronic treatment administration records (eTAR), behaviour tracking records, resident assessments, and relevant policies and procedures
