s. 85. (3) The licensee shall seek the advice of the Residents' Council and the Family Council, if any, in developing and carrying out the survey, and in acting on its results. 2007, c. 8, s. 85. (3).

Findings/Faits saillants :

1. The licensee failed to seek the advice of the Residents' Council in developing and carrying out the satisfaction survey. On October 22, 2012 the inspector interviewed resident 1111 who reported that the Residents' Council was not consulted in developing and carrying out the satisfaction survey. Staff member S-001 confirmed on October 22, 2012 that the licensee did not seek the advice of the Residents' Council in developing and carrying out the satisfaction survey.
