The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): October 30-31, November 1, 4-6, 2019.

This inspection included the following critical incident reports (CIR): Log #'s 013178-19 (CIR #2879-000024-19), 013503-19 (CIR #2879-000025-19), 014442-19 (CIR #2879-000026-19), 018518-19 (CIR #2879-000034-19), 019218-19 (CIR #2879-000036-19), 019625-19 (CIR #2879-000038-19), 020376-19 (CIR #2879-000042-19) related to an incident that caused injury to a resident for which the resident was taken to hospital and which resulted in a significant change in the resident's health status. -Log #013050-19 (CIR #2879-000023-19) related to resident to resident alleged abuse.

During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSWs), Registered Nurses (RN), Registered Practical Nurses (RPNs), the Director of Care (DOC), and the Administrator.

In addition, the Inspector reviewed resident health care records, observed resident care and resident to resident interactions.
