1. The licensee had not ensured a final report was submitted to the Director within 10 days of becoming aware of alleged incidents of abuse.

The home had made a preliminary report indicating an investigation had commenced regarding alleged abuse, however, the final report had not been submitted within 10 days. The home's internal investigation had not been completed, therefore all the information required in a final report was not yet available. The home failed to update the report requesting a new date for completion as specified by the Director.

The home's management confirmed the final report was not complete and that a new date for completion had not been arranged with the Director. [s. 104. (3)]
